Appropriate engineering controls	<p>Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. Well-designed engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to provide this high level of protection. The basic types of engineering controls are:</p> <p>Process controls which involve changing the way a job activity or process is done to reduce the risk.</p> <p>Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment. Ventilation can remove or dilute an air contaminant if designed properly. The design of a ventilation system must match the particular process and chemical or contaminant in use.</p> <p>Employers may need to use multiple types of controls to prevent employee overexposure.</p>

1,1-DICHLORO-1-FLUOROETHANE	<p>CFCs are absorbed following inhalation, oral ingestion, or through skin contact. Inhalation is the most important route of entry, and exhalation is the most significant route of elimination. They can cause irregular heartbeat, airway irritation, tingling sensation, humming in the ears, apprehension, slurred speech and decreased performance in psychological tests and consciousness. There could also be reduced lung function. Skin application causes various degrees of skin irritation but no other significant effects. They have no potential to cause cancer or mutation. For dichlorotrifluoroethane (HCFC -123) and dichloropentafluoropropane (HCFC-225)</p> <p>Prolonged inhalation of high concentrations of HCFC-123 vapour may cause temporary nervous system depression with anesthetic effects such as dizziness, headache, confusion, incoordination, and loss of consciousness. With gross overexposure (greater than 20% concentration), a temporary alteration of the heart's electrical activity with irregular pulse, palpitations, or inadequate circulation may occur. Similar effects are observed in overexposure to CFC-11. Inhalation may cause liver effects with extended high-level exposures. Intentional misuse or deliberate inhalation of HCFC-123 may cause death without warning.</p> <p>Exposure in the range of 650 to 1,000 ppm with HCFC-225ca produced effects on the liver in rodents, but a minor effect in a primate. Exposures in the range of 1,000 to 5,000 ppm with HCFC-225cb resulted in only marginal effects in rodents or a primate</p> <p>If HCFC-123 vapours are inhaled at a concentration of 20,000 ppm or greater, the heart may become sensitized to adrenaline leading to cardiac irregularities and, possibly, to cardiac arrest. Similar effects are observed with CFC-11 at concentrations in air of 3,500 ppm or greater. The likelihood of these cardiac problems increases under physical or emotional stress.</p> <p>Disinfection byproducts (DBPs) are formed when disinfectants such as chlorine, chloramines and ozone react with organic and inorganic matter in water. Animal studies have shown that some DBPs cause cancer. To date, several hundred DBPs have been identified. Numerous haloalkanes and haloalkenes have been tested for cancer-causing and mutation-causing activities. In general, the potential to cause genetic toxicity is dependent on the nature, number and position of halogen(s) and the size of the molecule.</p> <p>Haloalkenes are of concern because of the potential to generate genetically toxic intermediates after epoxidation. The concern for haloalkenes may be diminished if the double bond is internal or sterically hindered.</p> <p>The cancer concern levels of the 14 haloalkenes and haloalkanes, have been rated, based on available screening cancer bioassays and data on genetic toxicity. Some individuals may be genetically more susceptible to brominated THMs than others.</p> <p>Six, two and one haloalkanes/haloalkenes have been given low-moderate, marginal and low concern, respectively.</p> <p>Dichlorofluoroethane has low acute toxicity at low-level oral or skin exposures. It can be a mild eye irritant. There was no effect on development at low doses. However, at higher doses there may be a decrease in body weight, with increased risk of testicular enlargement and tumour formation, growth retardation and death. Repeated inhalational exposure may increase levels of cholesterol and glucose.</p> <p>These substances have low potential for accumulation in the body. HCFC 141b is not readily broken down in the body. The predominant degradation of HCFC 141b will occur in the air, but at a very slow rate. Acute environmental toxicity has been documented with death of zebra fish, daphnia, and algae.</p>
